TAX COLLECTION: I would prefer tax payments by mail. Taxes will be dated by postmark, and a receipt for paid taxes will be furnished when a SELF-ADDRESSED STAMPED ENVELOPE is included with your tax payment. Keep in mind that if you use extra postage to pay your taxes, I will likely need extra postage to return your receipts. Please be sure to include the appropriate coupon from the lower portion of your tax bill (keep the tax bill itself). Make your check payable to TOWN OF NEPEUSKUN. I will be available at my home on FRIDAY, DECEMBER 28, 2018 from 9 a.m. to 6 p.m. and again on MONDAY, JANUARY 28, 2019 from 9 a.m. to 6 p.m. Tax collection and receipting will now be web based and processing time will be dependent on our internet connection. For those who come to my home to pay, I may not be able to have your receipt until a later date.

SECOND INSTALLMENT: Payment should be made payable to and mailed to: <u>WINNEBAGO COUNTY</u>

TREASURER. DO NOT send second installment to the Town Treasurer.

I MUST HAVE YOUR **VETERINARIAN'S CERTIFICATE** VERIFYING THE DOG'S <u>NAME</u>, <u>COLOR</u>, <u>BREED</u>, WHETHER IT'S <u>MALE OR FEMALE</u>, (<u>NEUTERED OR SPAYED</u>) and <u>DATE OF LAST RABIES SHOT</u>, <u>EXPIRATION</u> <u>DATE</u>, <u>TYPE OF VACCINE & MANUFACTURER'S SERIAL NUMBER</u> BEFORE ISSUING A LICENSE. The certificate WILL be returned to you. If the dog is a combination of breeds, I must have a <u>GOOD DESCRIPTION</u> of the dog.

LOTTERY CREDITS: If a lottery credit does not appear on your tax bill, you can still claim one. Who qualifies? Owners of a home in Wisconsin who use the home as their primary residence on January 1 of the year in which property taxes are levied. "Primary residence" is defined as the home where an individual lives more than six months of the year. If temporarily absent, it is the home to which the owner returns. Only one primary residence may be claimed. Renters do not qualify. Please contact the Town Treasurer to claim a credit.
