**RECYCLING UPDATE:** After the September 21<sup>st</sup> recycling drop-off day, someone contaminated the commingled container with scrap windows and scrap wood (remodeling demolition), plus two televisions. Unfortunately, this load could not be credited as recyclables and was charged to the Town as trash. If you have any information on who may be responsible, please contact any Town official. Please refer to the information sheet with your tax bill for a review of what items are allowed for drop-off.

GARBAGE PICKUP – Garbage pickup is available in the Town. Contact Jon Schure for more information at 920-361-2970. Dumpster service for garbage is available in our town for a fee from Veolia and Waste Management. Talk to a neighbor to share the cost of a dumpster. Veolia (Omro), Waste Management (Berlin) or Winnebago County landfill (Oshkosh) have available garbage drop-off for a fee. Composting of organic post consumer waste is recommended.

**Farmland Preservation Program** – Those landowners who have enrolled should have been in contact with the Winnebago County Land and Water Conservation Dept. to verify that they have met the required performance standards so that they will be in compliance for the 2013 tax credit.

### **New Town Ordinance: Fire Protection and Burning Ordinance**

This ordinance was adopted on December 16, 2013. The main features of it are: Establishing uniform fees for fire related services for the entire Town – whether served by the Ripon or Berlin Fire Departments. New regulations on open burning are also included. This ordinance does not make burning permits a requirement. A copy of the new ordinance is available from the Town Clerk or on the Town website. The phone number to call if you are having a controlled burn is still **920-236-7300** (Winnebago County Dispatch).

STRAY ANIMALS: If you are bothered by stray animals you should contact the Town Constable – Richard Fernau at 920-748-9427 or 920-585-8456. If you know the owner of the animal, a friendly call to the owner may be more effective and preserve a good relationship with your neighbor. The fine from the Winnebago County Sheriff's Dept. is over \$200 for a stray dog. Please be sure to get your dogs licensed - IT IS THE LAW - which will require a rabies vaccination.
