The most recent meeting of Rush Lake Watershed Restoration, Inc. was held on June 18, 2009. Discussion included spring water levels, Waukau carp trap repairs, new carp gates for the dam, additional dredging at the South landing to enhance winter carp removal, and proposed cattail spraying to be done in 2009. Also, president Doug Bohn proposed that an additional member be

added to the Board of Directors who would be considered a “member at large” and probably would be someone who is not a local resident but has shown exceptional interest in the Rush Lake restoration project. Additional action on all these matters will be considered at the next meeting, which is scheduled for Thursday, September 17, 2009 at 7:00 p.m. at the Waukau Youth Center. Sediment in Road Ditches – The Town has experienced a significant expense in past years regarding cleaning sediment from road ditches resulting from soil erosion of adjacent properties. As a result, the Town Board passed a resolution at its April 20, 2009 meeting stating that the cost of this type of ditch cleaning may be allocated to adjacent property owners pursuant to Section 86.02 of the Wisconsin Statutes. The Board will have discretion as to the amount to be charged and how it would be allocated. Please contact the Winnebago County Land and Water Conservation Department for assistance with soil erosion control practices on your property if this situation possibly exists.
