PROCEEDINGS OF THE REGULAR MONTHLY MEETING OF THE NEPEUSKUN TOWN BOARD HELD MONDAY, FEBRUARY 17, 2014.

The regular monthly meeting of the Town Board of the Town of Nepeuskun was called to order at 7:02p.m. at the Nepeuskun Town Hall, 1475 County Road E with all board members and Zoning Administrator Trochinski present for the meeting.

Clerk Pinnow certified that an official notice for this meeting had been posted at the three official posting sites within the Town on February 15, 2014.

Motion was made by Supervisor Luker and second by Supervisor Heise to approve the agenda for the February 17, 2014 meeting. Motion carried unanimously.
