Motion was made by Supervisor Heise and second by Supervisor Wargula to approve the agenda for the November 16, 2015 meeting. Motion carried unanimously.

County Sheriff's Deputy Report:

Sheriff's Deputy Putzer was present for the meeting. Discussion was held regarding speed limits through the village area of Rush Lake.
