PROCEEDINGS OF THE REGULAR MONTHLY MEETING OF THE NEPEUSKUN TOWN BOARD HELD MONDAY, APRIL 18, 2016.

The regular monthly meeting of the Town Board of the Town of Nepeuskun was called to order at 7:03pm at the Nepeuskun Town Hall; 1475 County Road E with all Board members present, Zoning Administrator Trochinski absent and 6 citizens present for the meeting.

Clerk Pinnow certified that an official notice for this meeting had been posted at two of the official posting sites on April 18, 2016.

Motion was made by Supervisor Heise and second by Supervisor Wargula to approve the agenda for the April 18, 2016 meeting. Motion carried unanimously.
