PROCEEDINGS OF THE REGULAR MONTHLY MEETING OF THE NEPEUSKUN TOWN BOARD HELD MONDAY, JANUARY 16, 2017.

The regular monthly meeting of the Town Board of the Town of Nepeuskun was called to order at 7:02pm at the Nepeuskun Town Hall; with all members and five citizens present for the meeting and Zoning Administrator Trochinski absent (excused).

Clerk Pinnow certified that an official notice for this meeting had been posted at the official Town Hall posting site and the Town Website on January 15, 2017.

Motion was made by Supervisor Heise and second by Supervisor Wargula to approve the agenda for the January 16, 2017 meeting. Motion carried unanimously.

County Sheriff's Deputy Report:

No one present for the meeting.

Motion was made by Supervisor Wargula and second by Supervisor Heise to approve the minutes of the December 19, 2016 Regular Monthly Board Meeting. Motion carried unanimously.

Treasurer's report for December 31, 2016: Township Account, \$40,038.48, Fire & Ambulance Equipment Account, \$50,269.85, Fire Number/Address Sign Account, \$0.00.

Treasurer's report for January 16, 2017: Township Account, \$206,937.50, Fire & Ambulance Equipment Account, \$50,269.85. Motion made by Supervisor Heise and second by Supervisor Wargula to approve the Treasurer's Reports for December 31, 2016 and January 16, 2017. Motion carried unanimously.

## **New Business:**

Emma Pinnow – Girl Scout Troop #6108 presented on her Silver Award proposal to place a Little Free Library at the Nepeuskun Town Hall. Motion was received by Supervisor Wargula and second by Supervisor Heise to approve the placement of the Little Free Library at the Nepeuskun Town Hall. Motion carried unanimously.

Discussion was held with Jay Roberts of Utica First Responders regarding enabling Utica First Responders to assist with ambulance calls in the eastern area of the Town of Nepeuskun. They would propose expanding the sections covered to the west.

Motion was made by Supervisor Heise and second by Supervisor Wargula to approve of the renewal of Conditional Use Permit #01-12 for LeDoiyt Enterprises, Ltd. Parcel# 0140150. Chairman Bahn explained that the Town has a junk and nuisance ordinance and if there were to be a complaint filed, they would have to investigate further. Motion carried unanimously.

Motion was made by Supervisor Wargula and second by Supervisor Heise to approve of the denial of Conditional Use Permit #03-16 and approve recommendations for compliance for Val Vilwock Parcel# 01405540501. Motion carried unanimously.

Motion was made by Supervisor Heise and second by Supervisor Wargula to approve of road paving project #2 as per Jon Groth's email (dated 1/6/2017) for Koro Road (#1963-#2052) for a total of \$28,000 for 2017 using LRIP(TRIP) funds. Motion carried unanimously.

Motion was made by Chairman Bahn and second by Supervisor Wargula to approve check numbers 8360-8382 in the amount of \$471,643.64. Motion carried unanimously.
