- 7) Review/Approve Definition of Agri-tourism: The coming together of the continued use of lands, and the open rural character of the community, with the tourists (visitors) to experience the outdoors, the leisure pace of life, and in many instances, enjoy the nutrition of locally source foods.

Agri-tourism shall be conducted in a manner consistent with the Town’s Comprehensive Plan. The stated purposes of land zoned A-1 (Chapter 14) A-2 (Article 4 5.4.2(1) 5.4.3(1) preserving sensitive areas with the overall goal to promote and preserve the Town’s rural environment.

Agri-tourism in A-2 Districts will require a Conditional Use Permit (Article 8) and subject to the limitations identified in Exhibit 2 of the Town Code.
